Upon entering the application, the user's browser automatically sends the following information to the application server:

- the IP address of the computer sending the request;
- the website from which access is made (referrer URL);
- the browser used, and if necessary, the computer's operating system; and
- the name of the access provider.
- information about errors that occurred while browsing our website;
- Information collected via cookies or other similar technologies.

This data is processed by IBE PIB for the following purposes:

- providing services electronically in the scope of making content available on the website (the legal basis for processing is Article 6(1)(b) of the GDPR — processing is necessary for the performance of a contract);

- analytical and statistical purposes (the legal basis for processing is Article 6(1)(f) of the GDPR — the legitimate interest of the administrator in conducting analysis of users' activity and preferences to improve the functionalities of the provided services);

- possible establishment, exercise or defence of legal claims, based on the legitimate interest of the administrator in protecting its rights.

## Cookies

This website uses cookies. These are small text files that contain information and are saved by the web browser on the user's computer or mobile device's hard drive or memory when they visit the website.

The website uses cookies to enable browsing and use of its functions, and to collect and analyse information about users' visits, such as number of visits, average time spent on the website, browsing history, location, browser and system information, as well as other statistical data. This information is used to provide content that is relevant and tailored to users' interests. Where any of the cookies used by IBE PIB process personal data, this is done in accordance with Article 6(1)(f) of the GDPR, i.e. based on the administrator's legitimate interest in ensuring the website functions optimally and is user-friendly.

## Managing cookies

Cookies that are necessary for using the website are automatically installed on the user's device as they are necessary for providing the telecommunications service (data transmission for displaying content) and users cannot refuse them if they wish to use the service.

## Form

If the form for reporting website errors is used, the user's data (especially the email address and any other information provided in the report) will be processed to handle the report and provide a response.

This data is processed by IBE PIB based upon the user's voluntary consent (Article 6(1)(a) of the GDPR).

Providing personal data for the purpose of using the contact form is voluntary but necessary for handling the report (in terms of email address).

## Data recipients

Recipients of personal data may include individuals or entities to whom the administrator is obliged to disclose data based on legal provisions. Data may be entrusted for processing to IT and hosting service providers.

## Data processing period:

The user's personal data will be processed for as long as is necessary to achieve the purposes for which the data is being processed, or until an objection is raised (if the basis for processing is the legitimate interest of the administrator), whichever occurs earlier. If the basis for processing is the User's consent, personal data will be processed until consent is withdrawn or the reasons justifying data processing cease to exist.

The user has the following rights:

The right to access their data and receive a copy thereof; the right to rectify their personal data; the right to erase their personal data; and the right to restrict the processing of their personal data under the rules and in the cases provided for in the GDPR provisions.

Regarding data processed on the basis of consent, the User has the right to withdraw the consent at any time. Withdrawal of consent does not affect the lawfulness of processing carried out before its withdrawal.
